SUBJECT: Adoption of a policy and procedure regarding lot vegetation maintenance

and vegetation encroachment on streets and sidewalks.

PURPOSE: To provide notice of the Association's adoption of policies and

procedures of lot vegetation maintenance and vegetation encroachment

on streets and sidewalks.

AUTHORITY: The Declaration, Articles and Bylaws of the Association and Colorado

Law.

EFFECTIVE

Date: September 20, 2016

RESOLUTION: The Association hereby adopts the following policy to be known as

Section 9.50 of the Amended and Restated Architectural Standards, titled Lot Vegetation Maintenance And Vegetation Encroachment on Streets

and Sidewalks.

9.50 Lot Vegetation Maintenance And Vegetation Encroachment on

Streets and Sidewalks

On all unimproved (vacant) lots in Tamarisk Village, Tamarisk Meadows, Monument Creek Village, Stone Ridge Village and Willow Creek Village all vegetation, on the entire lot, shall be mowed and

maintained to a height not to exceed six inches (6").

On all unimproved (vacant) lots in Battlement Creek Village, Sections 1 & 2, all vegetation located in the first eight feet (8') of the lot, measured from the back of the street curb on all streets shall be mowed and

maintained to a height not to exceed six inches (6").

To allow unimpeded pedestrian and vehicular travel within the community, no tree, shrub, plantings or landscaping items on any lot shall be allowed to extend into any street or sidewalk right-of-way. For purposes of this policy, a street right-of-way shall include the airspace directly above the street (from curb line to curb line) to a height of 8 feet (8') and a sidewalk right-of-way shall include the airspace directly above

public sidewalks to a height of 8 feet (8')

Trees, shrubs or other plantings that have a canopy extending into any street or sidewalk right-of-way shall be pruned to eliminate foliage in the street or sidewalk right-of-way as defined above. Any such canopy located above the 8 foot (8') height can remain in place over the street and sidewalk right-of-way. An illustration depicting these vegetation encroachment restrictions into the street and sidewalk right-of-ways is attached hereto as Exhibit A.
